This meeting is open meeting, open to the public, subject to the Open Meetings Law of the State of Texas, and as required by law, notice is hereby posted on Friday, January 20, 2012 before 5:00 p.m., providing time, place, date and agenda thereof. The meeting facility is wheelchair accessible and accessible parking spaces are available. Requests for accommodations or interpretive services must be made 48 hours in advance of this meeting.

### **Rules for Citizen's Participation:**

The Water Commission welcomes citizen participation and comments at all of their Commission Meetings. As a courtesy to your fellow citizens and out of respect to our appointed officials, we must request that if you wish to speak, that you follow these guidelines.

- a. Direct your comments to the entire Commission, not to an individual member, nor to the audience.
- b. Show the Water Commission the same respect and courtesy that you expect to be shown to you.
- c. Limit remarks to three (3) minutes.

*NOTE: The Texas Open Meetings Act permits a member of the public or a member of the governmental body to raise a subject that has not been included in the notice for the meeting. However, any discussion of the subject **must be limited** to a proposal to place the subject on the agenda for a future meeting and any response to a question posed to the Commission is limited to either a statement of specific factual information or a recitation of existing policy. TEX. GOV'T CODE § 551.042.*

##### **Decorum Required:**

Any disruptive behavior, including shouting or derogatory statements or comments may be ruled out of order by the Presiding Officer. Continuation of this type of behavior could result in a request by the Presiding Officer that the individual leave the meeting, and if refused, an order of removal.

##### **Action by Commission Authorized:**

The Commission may vote and/or act upon any item within this Agenda. The Commission the right to retire into executive session concerning any of the items listed on this Agenda, and in accordance with Texas Government Code Section 551.071, to seek the advice of its about pending or contemplated litigation, settlement offer or on a matter in which the duty of attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct State Bar of Texas conflict with the Open Meetings Act and may invoke this right where the Attorney, the Mayor or a majority of the Governing Body deems an executive session is allow privileged consultation between the City Attorney and the governing body, if considered necessary and legally justified under the Open Meetings Act. The City Attorney may appear in person, or appear in executive session by conference call in accordance with applicable state law.

##### **Executive Sessions Authorized:**

This agenda has been reviewed and approved by the City's legal counsel and the presence of subject in any Executive Session portion of the agenda constitutes a written interpretation of Government Code Chapter 551 by legal counsel for the governmental body and constitutes an by the attorney that the items discussed therein may be legally discussed in the closed portion of


